2018 Dog Licenses

Do you own a dog over the age of 6 months and live in the Village of Rosalind? Do you care for a dog on a temporary basis exceeding 2 weeks? If you answered yes, the following schedule applies to you:

If paid by January 31, 2018 - \$20.00 per dog

If paid by February 28, 2018 - \$30.00 per dog

If paid by March 31, 2018 - \$50.00 per dog

If paid by April 30, 2018 - \$100.00 per dog

We will be mailing out invoices for any dogs that are currently registered with the Village. If you have any changes to make, please contact the Village Office.

As per the Dog Control Bylaw #251-17, if the 2018 Dog License is not paid by May 1, 2018, a violation ticket will be issued for any outstanding amount owing. If the violation is not paid within 30 days of issue, the balance of the ticket can be transferred to the property tax account. Please visit our website for a complete copy of our by-law.

PROPERTY TAXES

Property taxes were due August 31, 2017. Any property with an outstanding balance as of December 31, 2017 will receive an 18% penalty charge on January 2, 2018.

Water and Sewer Accounts

In January, 2018, you will be receiving your utility bill for Water and Sewer usage in November/December 2017. These will be due January 31, 2018. A 5% penalty will be applied to any outstanding amounts after the due date. Please note the Utility Bylaw #250-17:

Section 12

(c) In the event that any such utility bill shall remain unpaid after 60 days after billing date, the water supply to the property is subject to disconnection, and should the service be disconnected it may not be reconnected until the outstanding utility amount plus any dis/connection related fees as outlined in Schedule "A" are paid in full.

(d) The Village shall have the authority to turn off the water for any account in Arrears with two (2) weeks written notice.

NEW FOR 2018

Utility bills will now be sent out monthly, rather than bi-monthly. You will receive an invoice at the end of each month for utilities used. The Water and Sewer rates **have not changed**. Billing will be \$45.00 per month and are due on the last day of the month immediately following the month in which the services were provided. Payments can be made to the Village of Rosalind by cash, cheque, electronic funds transfer, email transfer or automatic debit/withdrawal.
