**A BYLAW OF THE VILLAGE OF ROSALIND IN THE PROVINCE OF ALBERTA TO APPOINT
COUNCIL AS BYLAW ENFORCEMENT OFFICER**

Pursuant to Section 555 and 556 of the Municipal Government Act, Chapter M-26, R.S.A. 2000, and Amendments thereto, the Council of the Village of Rosalind, requires that a Bylaw Enforcement Officer bylaw be established, enacts as follows:

INTERPRETATION

1. For the purpose of the Bylaw, the expression:
 - a. "Council" shall mean the Council of the Village of Rosalind.
 - b. "Municipality" shall mean the Village of Rosalind.
 - c. "By law Enforcement Officer" shall mean a law enforcement person of a municipality charged with enforcement of non-criminal bylaws, rules, laws, codes or regulations enacted by local governments.

SCOPE OF BYLAW

2. The Council hereby appoints itself as Bylaw Enforcement Officer for the Municipality.
3. The appointment shall continue until current council appoints an approved delegate.
4. An appointment may be terminated by the Council on one's month notice.
5. The duties of the Bylaw Enforcement Officer shall be the enforcement of all bylaws of the municipality, and:
 - a. To assist the administrator of the municipality by:
 - i. Serving notices and letters when requested by the administrator,
 - ii. Reporting to the municipal office any new development in the municipality,
 - iii. Reporting to the municipal office any municipal road or sign damage,
 - iv. Reporting to the municipal office any unsightly premises,
 - v. Reporting to the municipal office any dog infractions.

Whereas, any previous Bylaw Enforcement Officers bylaws for the Village of Rosalind be rescinded.
